- I. The meeting was called to order by President Burgess at 3:35 P.M.
- II. Mr. Johnson expressed his concern with the long waiting period for those persons involved in cases pending university level decisions on promotion and tenure.
- III. The chair asked for unanimous consent to approve the minutes of the University Senate meeting of March 12, 1973. There was no objection and the minutes were approved without exception.
- VI. A. Mr. Fisher reported for the Traffic Policy committee and responded to several questions from the floor. Although the report contained suggestions for possible future action, no immediate action was requested. The text of the report is attached to the permanent minutes.
- B. Mr. Ingmire reported for the University Curriculum and Academic Planning Committee and responded to questions from the floor. Most questions dealt with the advisability of a revised charge to the committee in light of the adoption of the Task Group Report on General Education. The text of the report is attached to the permanent minutes.
- VII. Mr. Meacham reported the Student Government Resolution on appeals to the Academic Court. It became apparent in discussion that the intent of the resolution is already established policy, albeit not widely known policy. Mr. Meacham requested no action of the Senate.
- VIII. The meeting adjourned at 4:45 P.M.
