	<ul style="list-style-type: none"> • Watermark Course Evaluation Update The committee has almost completed the list of questions for the Spring semester. The number of questions will be fewer than 10. These questions may be revisited in the future, though KBOR requires that we maintain a normed set, and the ability for departments and colleges to add additional questions will be implemented at a later time. • KBOR Update <ul style="list-style-type: none"> ○ October KBOR Visit to WSU – fifteen senators had a breakfast meeting with the Regents, the main topic of conversation was program review. The Regents were not aware that shared governance didn't happen as planned – that faculty advisory committee has only met three times with the rpk Group, and no town halls or other discussions with faculty were implemented. Regents Chair Rolph said that the rpk Group report would be one datapoint with the goal of effective program reviews using the right metrics. Provost Lefever suggested the approach for program reviews will likely be similar to what is done at WSU and that WSU should be talking about the return on investment of programs, as even low-enrollment programs bring unique experiences such as applied learning to our students and tying these programs to our strategic goals. Senator Allen asked that WSU internal review forms be modified to remove redundancy and be more readable to those outside the process. New Business	<ul style="list-style-type: none"> • DEI Update - Marché Fleming-Randle, VP and Chief Diversity Officer Each college has an individual assigned to be the college diversity officer and serves on the College Council DEI (CCDEI) committee. The goal is for each college to have their own DEI strategic plan. Last year the University DEI Plan was created, this year is focused on implementing the plan. Senators inquired about details of bias incident reports and how the DEI Plan interfaces with the Shocker Neighborhood. WSU has the Promise Scholarship, works with the Urban League, and Fleming-Randle personally goes to high schools. • 2022 Hanover Climate survey results for Faculty, Staff, & Students - Marché Fleming-Randle, VP and Chief Diversity Officer and Ashlie Jack, AVP Institutional Effectiveness. An overview of the Hanover Climate Survey (WSU login required) results were shared. The current goal is to connect the climate survey recommendations with the NISS recommendations, to the President's Goals, and to the strategic plan. 	<p>Note that Dr. Jack's report included our efforts to make good use of leftover food from WSU vendors, following up on question raised during Sept 12 President's report.</p>
